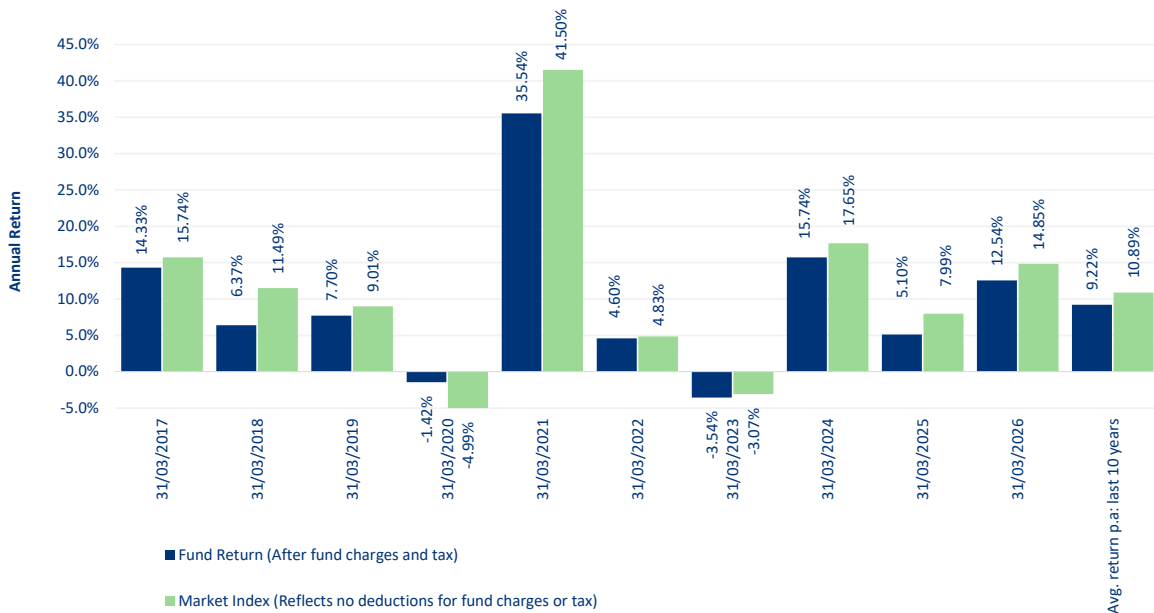

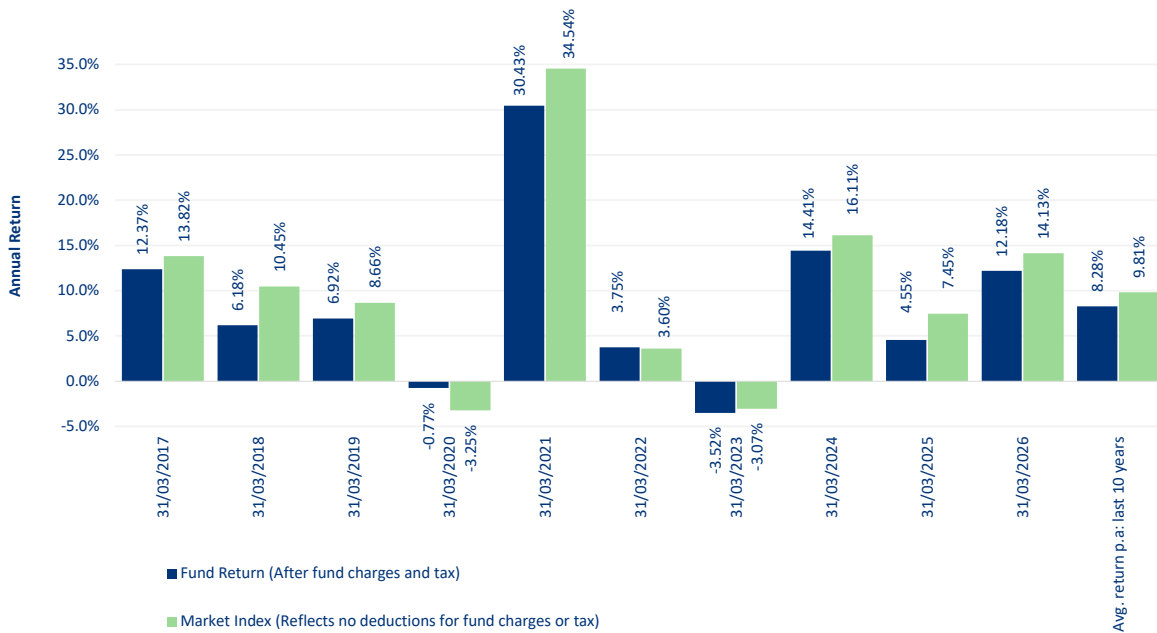

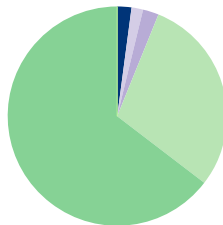

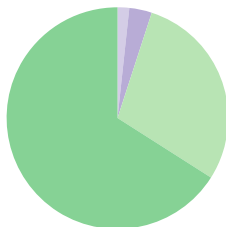

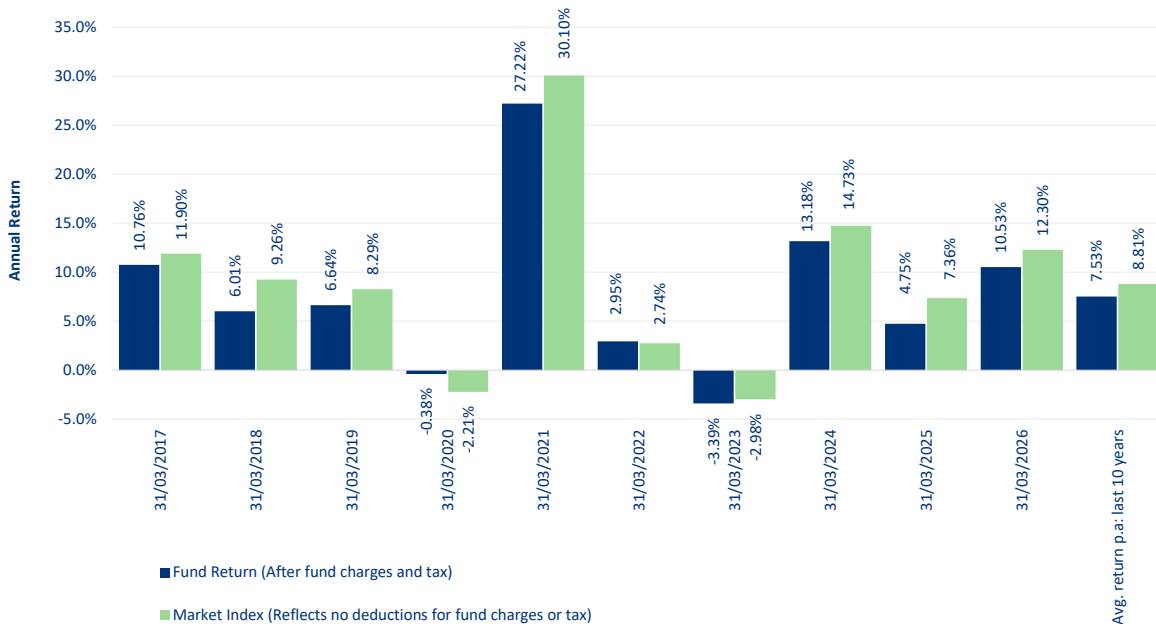

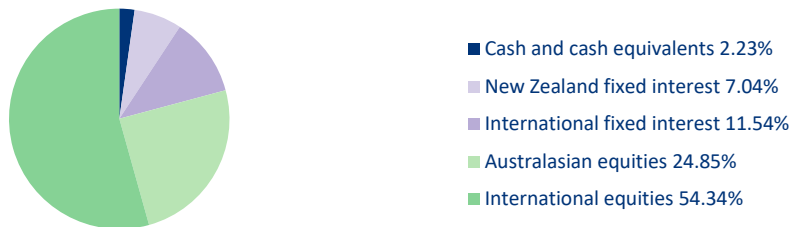

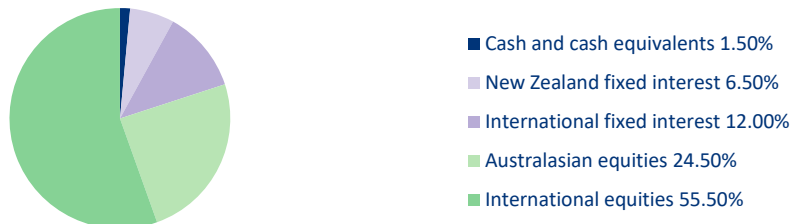

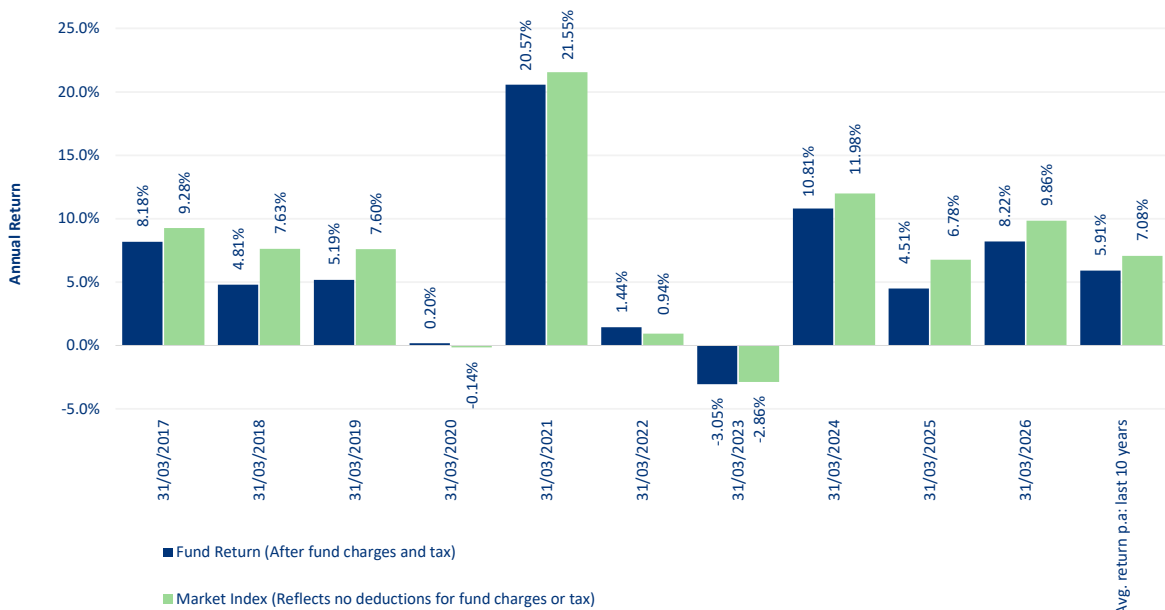

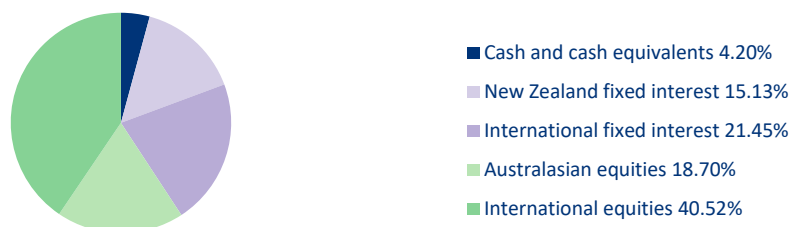

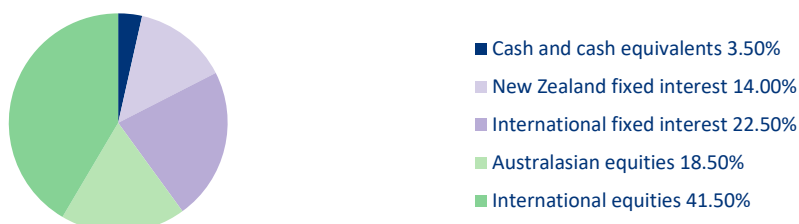

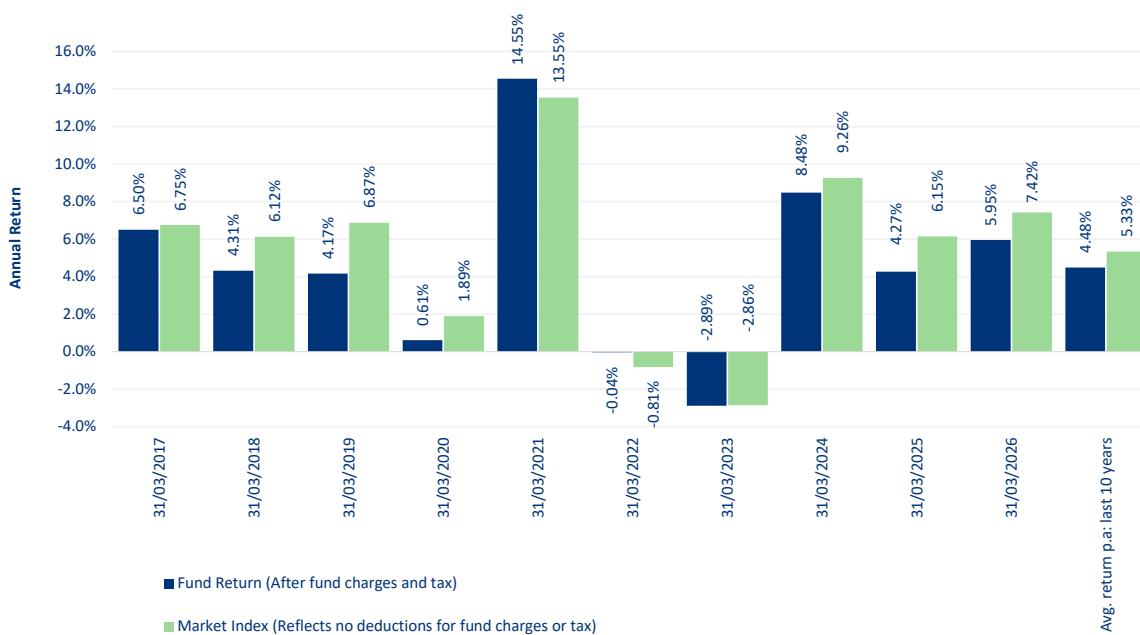

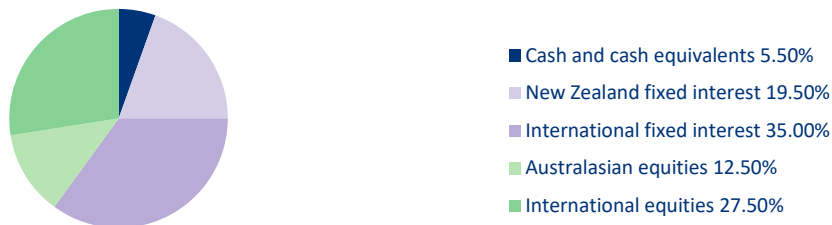

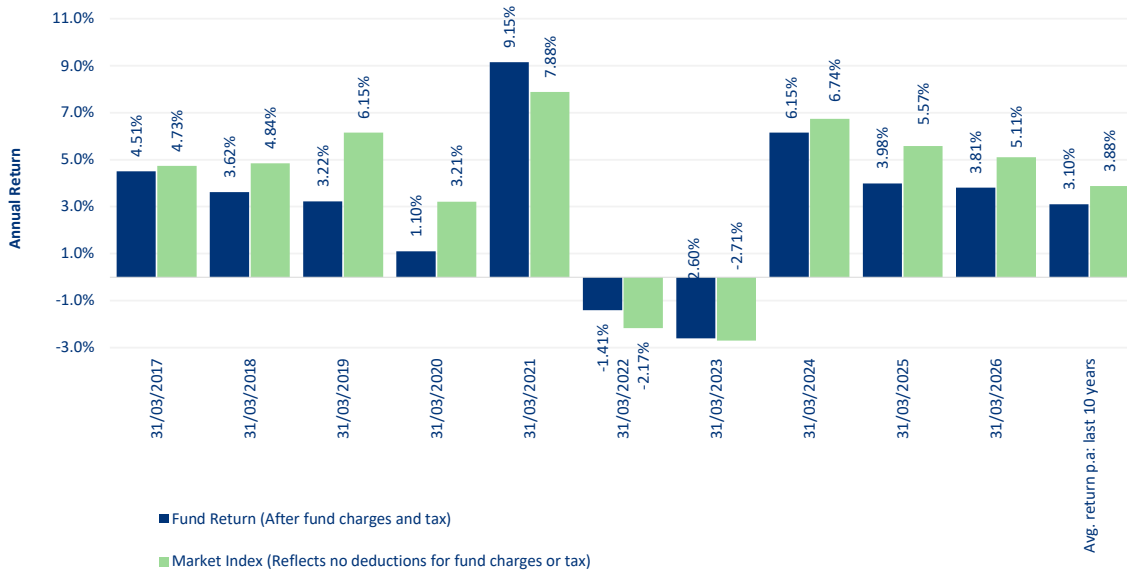

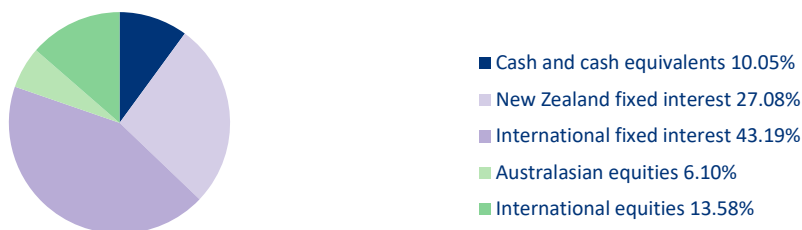

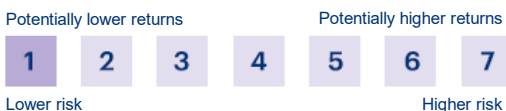

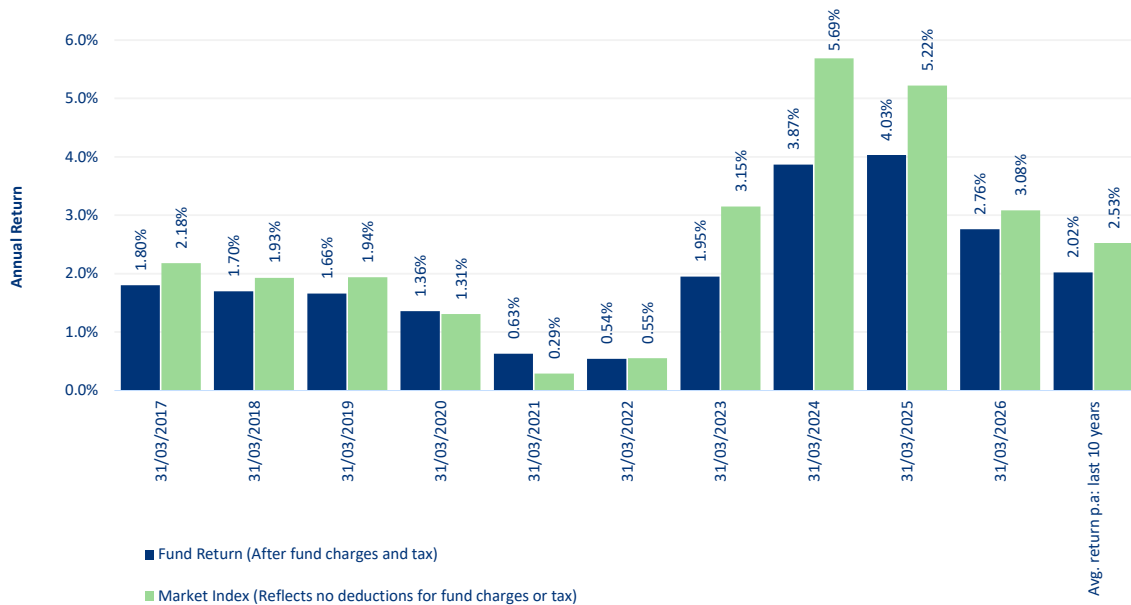

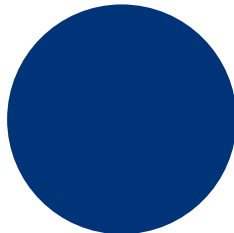

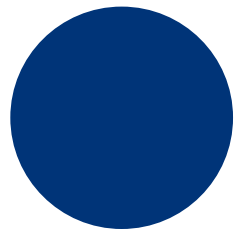
### Actual investment mix

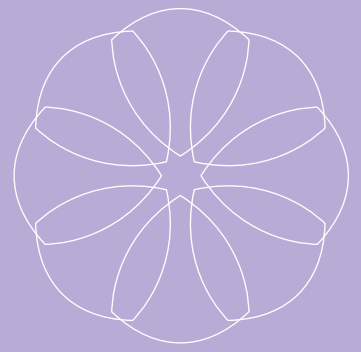
