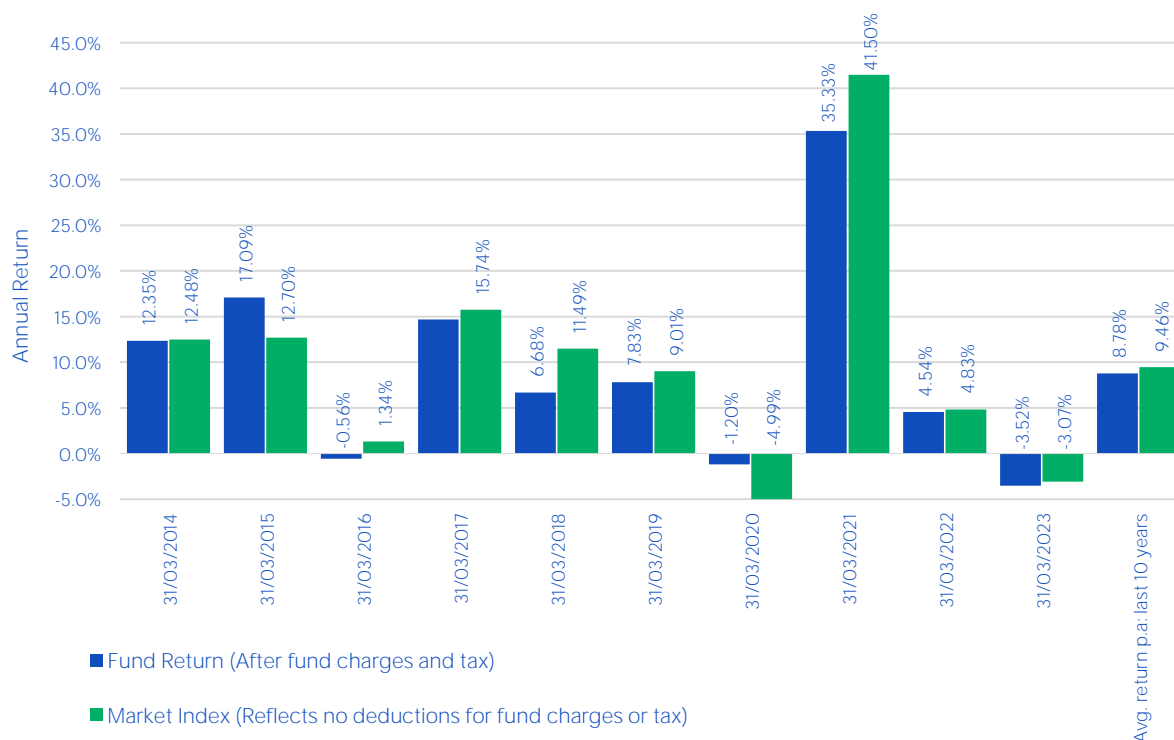

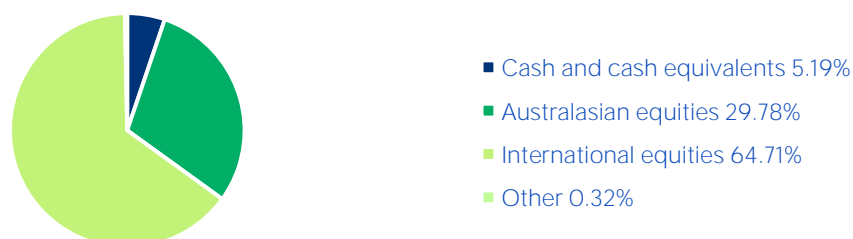

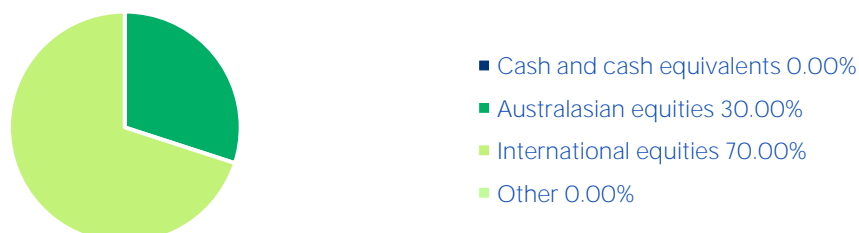

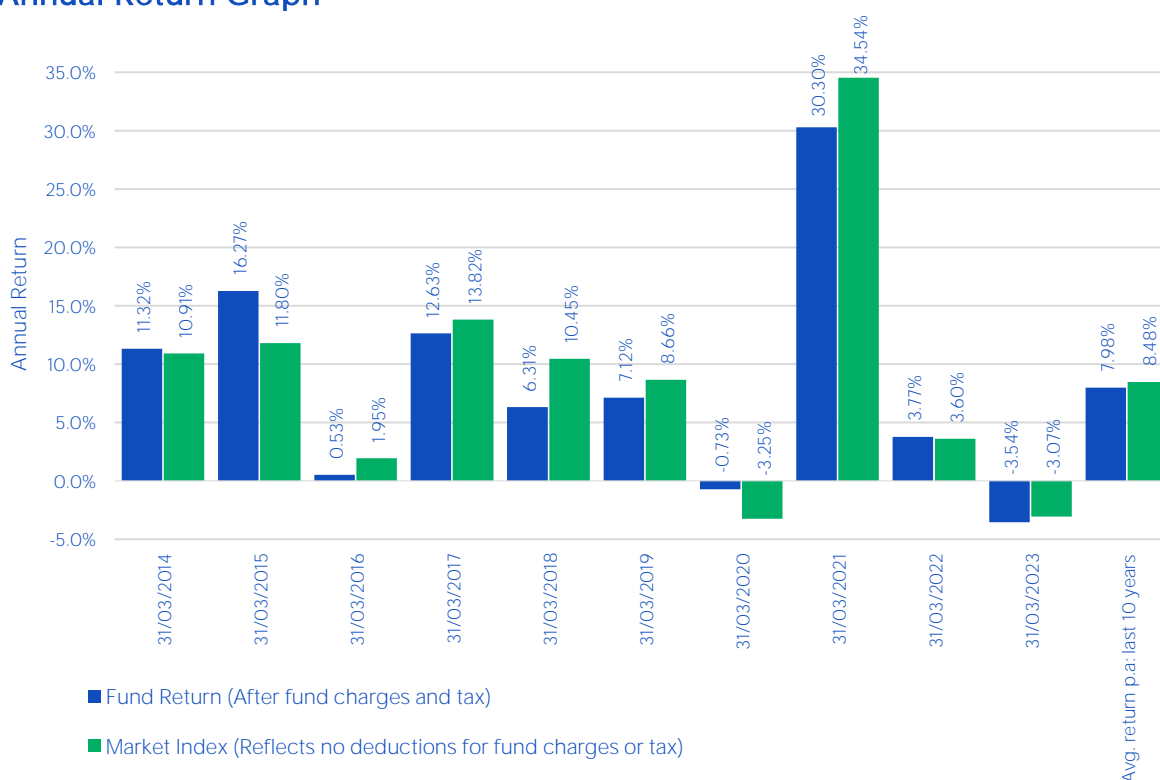

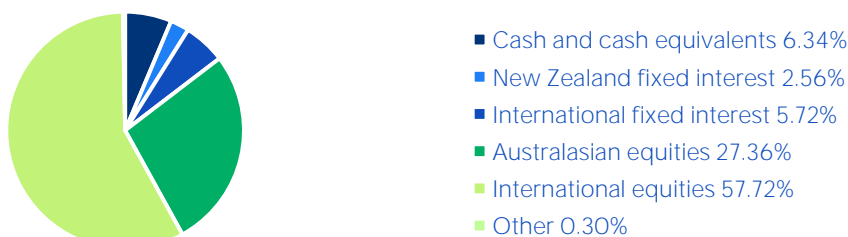

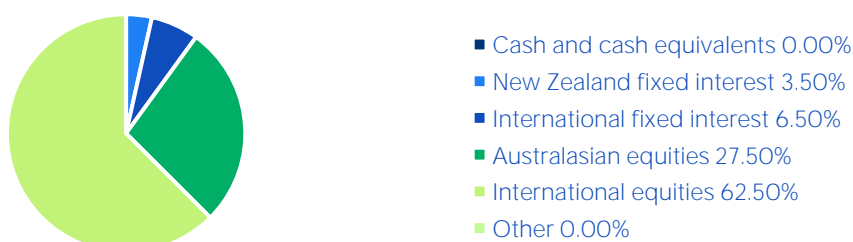

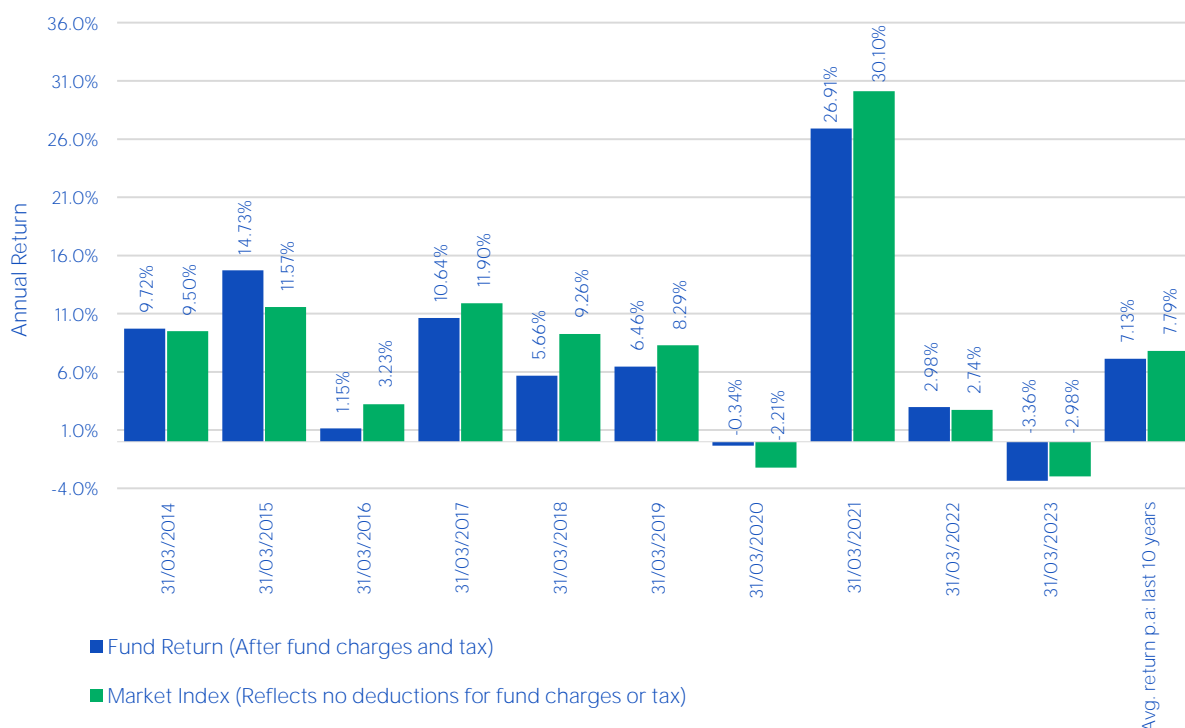

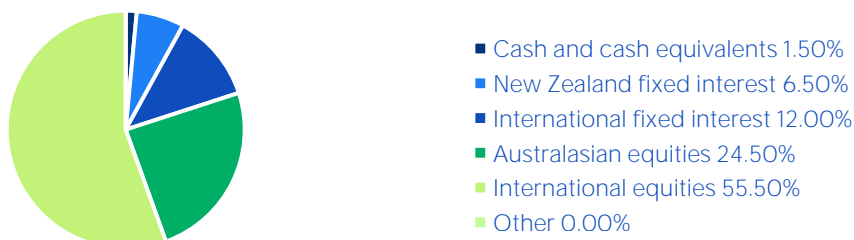

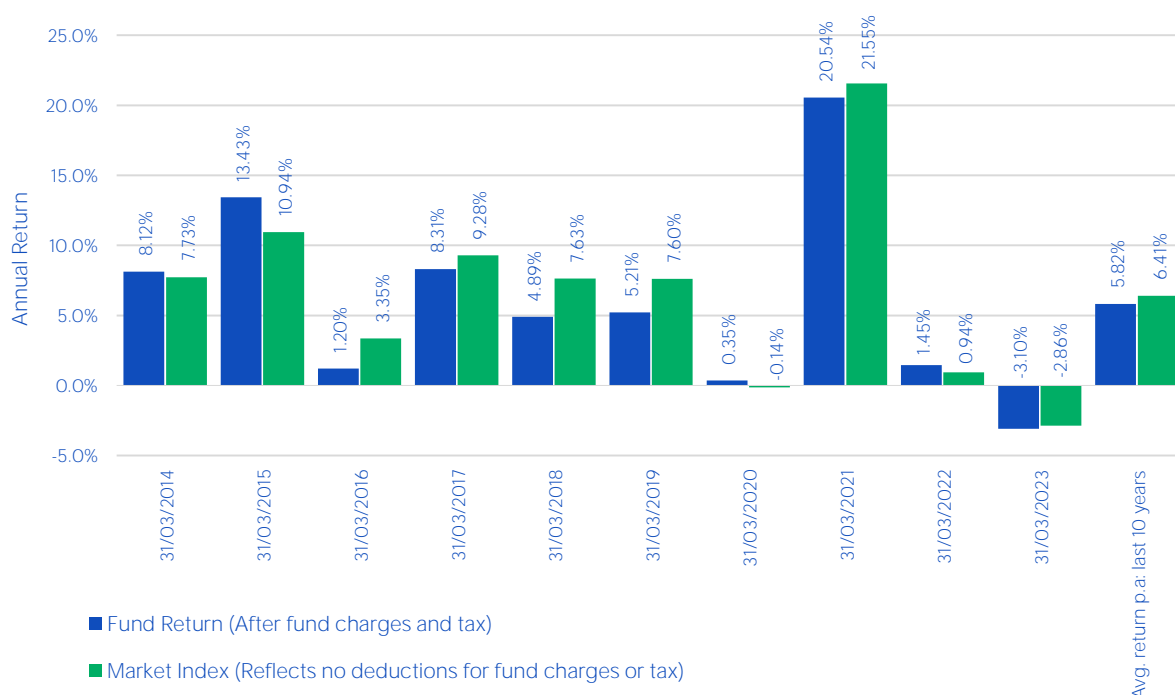

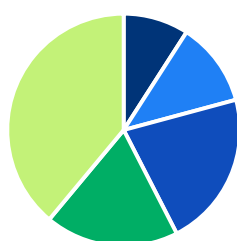

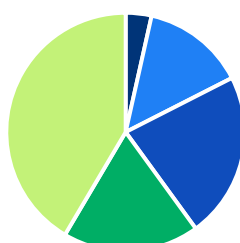

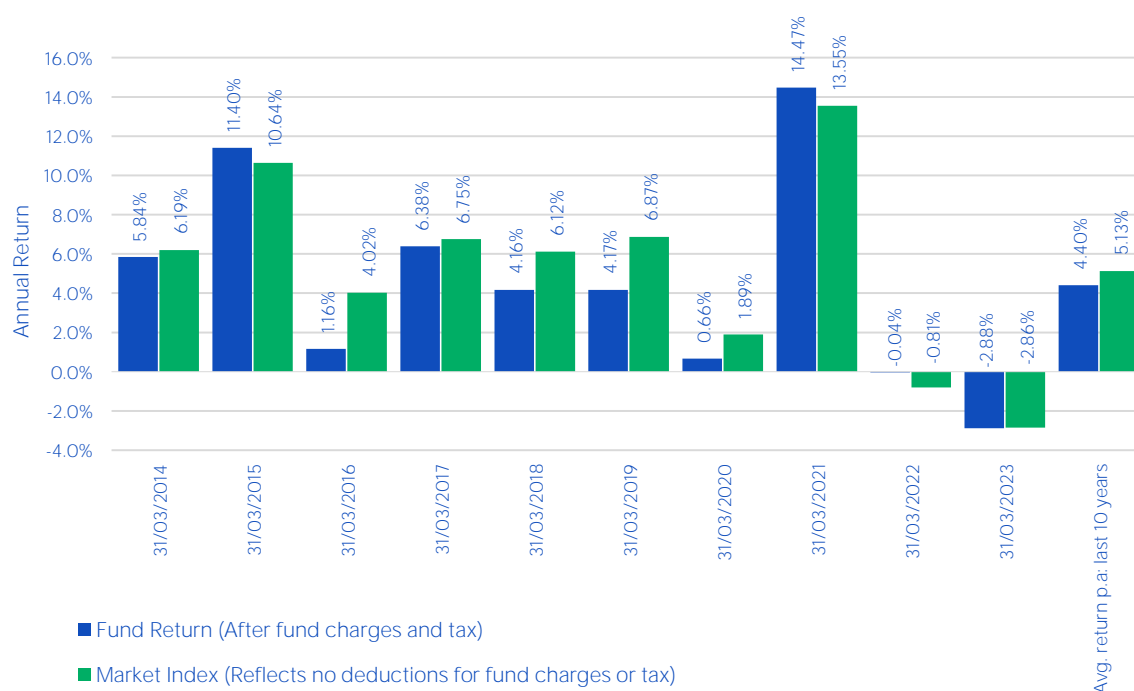

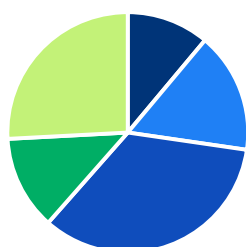

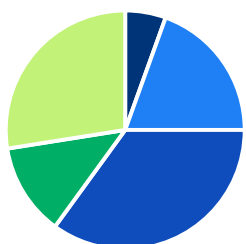
Actual investment mix

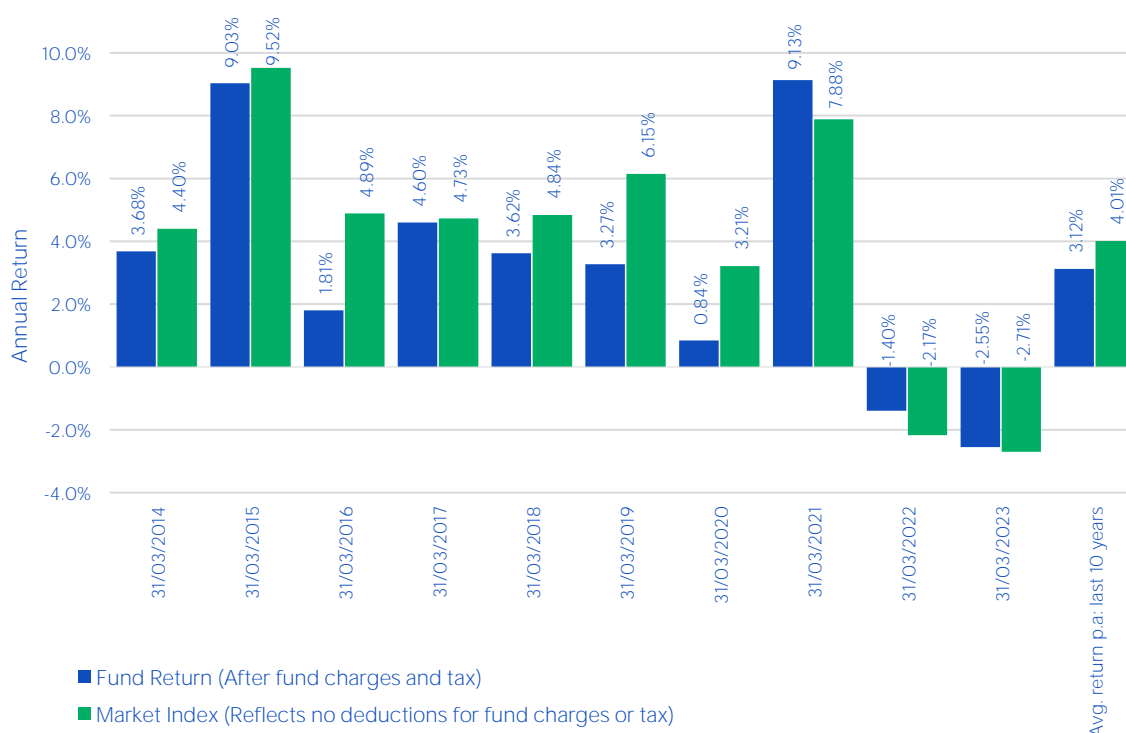

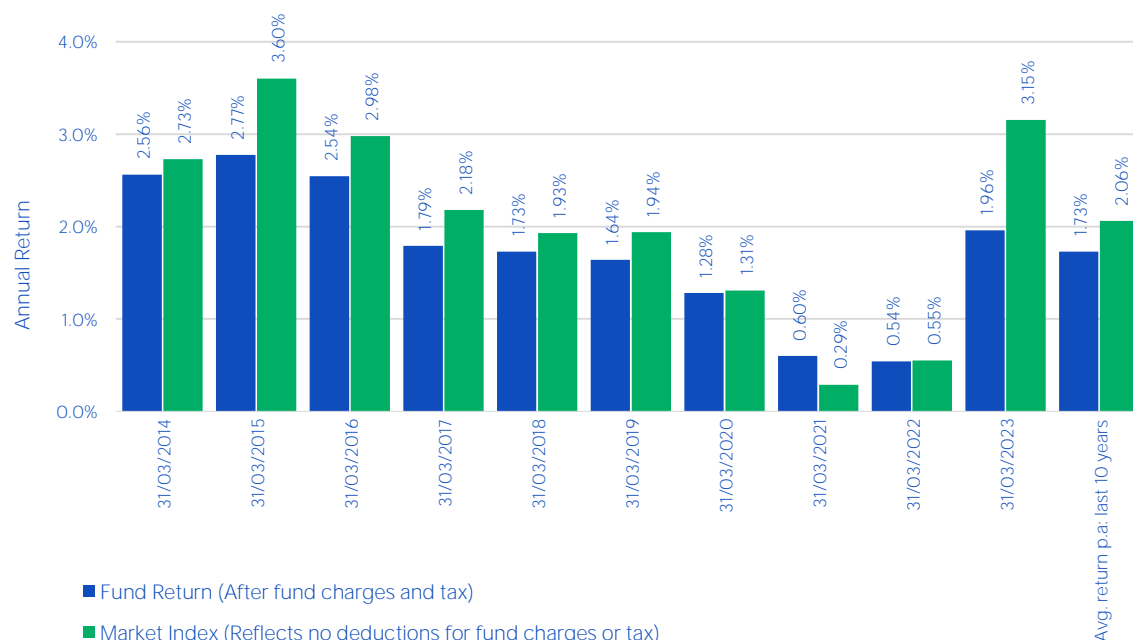

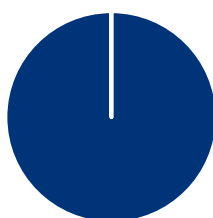

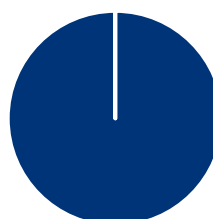
Actual investment mix
